DUE TO RECORDING SYSTEMS ISSUES, MINUTES MAY NOT BE COMPLETE

The City of La Vista Planning Commission held a meeting on Thursday, February 15th, 2018 in the Harold "Andy" Anderson Council Chamber at La Vista City Hall, 8116 Park View Boulevard. Chairman Gayle Malmquist called the meeting to order at 7:00 p.m. with the following members present: Mike Krzywicki, Gayle Malmquist, Mike Circo, Jason Dale, John Gahan, Kevin Wetuski, Kathleen Alexander and Tom Miller. Members absent were: Harold Sargus. Also in attendance were Chris Solberg, City Planner; Meghan Engberg, Permit Technician; Jeff Calentine, Deputy Director of Public Works; and John Kottmann, City Engineer.

7. Comments from the Planning Commission


8. Comments from Staff

Solberg let the members know that NPZA registration is still open and to let Meghan or himself know if anyone was still interested in going. He brought up doing another mobile tour in either May or June.


9. Adjournment
